Our Commitment to Child Privacy

When there is a need to communicate with children under the age of 13 for the acceptable purposes under this policy (for instance to confirm a race registration) we will use the email address of the parent, guardian or adult who has created the profile or registered the child for a race.

Information requested may include contact information (such as name and shipping address), and demographic information (such as zip code).
